72 Notice Convening Meeting

The Chief Executive read the notice convening the meeting.

73 Apologies for Absence

Apologies for absence were submitted on behalf of Councillors Mustafa Desai, Pete Hollings, Shaukat Hussain, Trevor Maxfield, Abdul Patel, John Pearson, Phil Riley, and Brian Taylor.

74 <u>Minutes of the Finance Council Meeting held on 27th February 2017</u>

RESOLVED – That the Minutes of the Finance Council meeting held on the 27th February 2017 be agreed as a correct record.

75 <u>Declarations of Interest</u>

Councillor Ron Whittle declared an interest in Agenda Item 10 (Treasury Management Update- Pension Contributions) – BwD representative on the Lancashire County Pension Fund Committee.

76 <u>Mayoral Communications</u>

The Mayor thanked all Organisations, Groups, Councillors and staff for all their support during his Mayoral year, and thanks were also passed to his chosen charities.

77 <u>Council Forum</u>

The Chief Executive advised that three questions had been received from Members of the Public under Procedure Rule 10 as follows:

Question from Mr Farrell to the Executive Member for Neighbourhood and Prevention, Arshid Mahmood:

My properties are my pension, so where will my pension come from (as a result of Selective Licensing effect on landlords)?

Councillor Mahmood provided a response to the question and supplementary question arising, advising Mr Farrell he was required to hold a licence for his property however the cost of the licence could be submitted as a cost against the tax he would pay on the income he received from the rent for the property. There were numerous costs associated with owning and renting out a property which would change over time and with changes in legislation, but the scheme was intended to benefit both landlords and tenants. Councillor Mahmood offered to meet Mr Farrell to discuss the matter further.

Question from Sabir Esa to Councillor Damian Talbot:

My question is about the recent by-election in the Higher Croft Ward. I would like a clear concise explanation of the errors which allowed an illegal candidate to be selected as the Labour Party candidate, especially as the same person stood in the previous May election for Labour in the Livesey with Pleasington Ward, thereby contravening the rules of the Electoral Commission on two occasions. I seek an assurance that Cllr. Talbot and the officers of the Labour Party will in future abide by the legal requirements for the selection of candidates, and when they are made aware of the cost of running this illegal by-election, would repay this sum of money to the Borough of Blackburn with Darwen, which was clearly caused by their incompetence.

The Leader of the Council, Mohammed Khan answered this question and supplementary question arising and advised that the cost of the by-election was approximately £8,800, and further to advice received from the Electoral Commission, the costs of thiswould be met by the Council. There would be no significant further costs relating to holding the by-election again as it would now be held on the same day as the General Election on 8th June. Councillor Khan outlined the process for selecting and verifying candidates, and advised that until it came to light, there was an innocent belief that the candidate was eligible, and he once again apologised for this genuine mistake further to the recent apology reported in the local press. Cllr Khan also confirmed that Councillor Talbot was not the agent for the candidate.

Question from Kieran Richards to Councillor John Slater:

The Council's policy on refuse collection is to implement alternate weekly collections and on green waste is to charge for collection. In a recent leaflet issued by your party a commitment is made that you will look to reintroduce weekly collections and free green waste collection. How does the Conservative leader propose to fund these commitments?

Councillor Slater provided a response to this question and supplementary question advising that his party would honour their manifesto pledge and reintroduce weekly refuse collections and scrap the 'garden tax', referring to increases in fly tipping since the introduction of the green waste collection charges. Councillor Slater advised that to fund these changes, the Executive Board would be reduced, the post of Deputy Chief Executive would be deleted and that some of the additional costs could be funded by borrowing amongst other changes.

78 The Motions Submitted under Procedure Rule 12

The Chief Executive announced that one Notice of Motion had been submitted under Procedure Rule 12 as follows:

'This Council calls on the Government to abandon its 'National Funding Formula' proposals, and to make a commitment to maintaining schools' funding so as to ensure both sustainability and the quality of our children's education.

On average every primary school pupil in England stands to lose approximately £400 in funding and every secondary school pupil stands to lose approximately £550 per pupil. Many schools in Blackburn with Darwen will lose considerably more than these averages. During debate Council Forum agreed that a Recorded Vote would be held. Councillor Maureen Bateson moved a minor amendment on the first line of Motion by adding 'any future' ahead of 'Government' and deletion of 'the'. This amendment was accepted by the Mover and Seconder and Council Forum and now became the Substantive Motion and now read as follows: 'This Council calls on any future Government to abandon its 'National Funding Formula' proposals, and to make a commitment to maintaining schools' funding so as to ensure both sustainability and the quality of our children's education.

On average every primary school pupil in England stands to lose approximately £400 in funding and every secondary school pupil stands to lose approximately £550 per pupil. Many schools in Blackburn with Darwen will lose considerably more than these averages. Children across our borough will lose out as a result of these proposals and this Council condemns the short-sighted failure to recognise the importance to the economy of investing in our next generation'.

79 <u>The Mayoralty 2017/18</u>

A report was submitted containing recommendations relating to the office of Mayor and Deputy Mayor in 2017/18.

It was reported that Annual Council formally appointed Members of the Council to the office of Mayor and Deputy Mayor for the forthcoming Municipal year. The Member appointed to the position of Deputy Mayor was normally appointed to the office of Mayor in the following year.

A report on the appointment of the Mayor was submitted to Council Forum each year, and in the event that the proportionality of the Council changed going forward in a way that would affect the nomination of Mayor for a particular year, a report on this matter would be submitted for Council's consideration - in 2018 there would be all –out Elections, so the position would need to be reviewed then.

It was the turn of the Conservative Group to nominate the Mayor, who in line with usual practice would usually be the serving Deputy Mayor, which in this case was Councillor Colin Rigby. It was also recommended that Council Forum agree the nomination of Deputy Mayor for 2017/18.

- 1) That in line with the usual practice of the Deputy Mayor in the current year serving as Mayor the following year, Councillor Colin Rigby OBE be nominated to serve as Mayor in 2017/18; and

80 <u>Treasury Management Update re: Payment of Employer Pension</u> <u>Contributions to the Lancashire Local Government Pension Fund</u>

A report was submitted which provided an update on the option taken, following triennial valuation of the Local Government Pension Scheme, to pay the annual deficit contributions for the next 3 years, as one upfront payment; in doing so the Lancashire Pension Fund would provide a discount for the early payment.

RESOLVED- That the payment of the annual deficit contribution due for 2017/18, 2018/19 and 2019/20 in advance in April 2017 be noted.

81 Policy and Corporate Resources Committee

In submitting the report of the Policy and Corporate Resources Committee, Councillor Jim Shorrock advised that the Annual Scrutiny Review on 8th May had been postponed and would now be held at the first meeting of the Committee in the new Municipal Year, and all Councillors were welcome to attend.

62 <u>Questions Received from Members under Procedure Rule 11</u>

The Chief Executive reported that two questions had been received under Procedure Rule 11 as follows:

For the Executive Member for Environment, Councillor Jim Smith from Councillor David Foster:

What decision making powers has the Executive Member delegated to his Assistant Executive Members?

Councillor Jim Smith advised in response to this question and associated supplementary question that his Assistant Executive Members had input into decisions, but that the final decisions were taken by himself. In terms of the Olive Lane Park decision referred to by Councillor Foster, he took account of the 'decisions' on this matter by his Assistant Executive Members and signed off the final decision.

For the Executive Member for Environment, Councillor Jim Smith from Councillor Roy Davies:

How much money has been spent by the Council on Olive Lane Park Darwen?

Councillor Jim Smith advised in response to this question and associated supplementary question that Olive Lane park was one of over 140 parks and open space sites maintained by the Council. The budget for parks and open spaces was not split down to individual sites, it was apportioned across all 140 sites. As Olive Lane park was not an individually costed site, it was not possible to provide any information from the Environment Portfolio on costs spent within the park. The total budget available for parks and open spaces for 2017/18 was £1,132,000. Councillor Smith confirmed that there were no plans to close the site and that ways of developing the park were being considered.



The Licensing Committee has established Sub-Committees consisting of three members of the Committee to deal with licensing applications. A rota of Members is drawn up with the Chair or Vice Chair leading each Sub-Committee meeting.

The Call-in Committee is chaired by the Vice Chair of Policy and Corporate Resources and is made up of eight other Members, appointed by Political Group Leaders according to the proportionality of the Council at the time.

3 MEMBERSHIP OF COMMITTEES

Members of the Executive Board cannot serve on any Overview and Scrutiny Committee.

Political parties make nominations to the Committees listed in 2 above. Places are allocated in line with the Local Government and Housing Act 1989 (ss.15-17) as regards proportionality. Political Group nominations will be circulated prior to the meeting of Annual Council.



APPOINTMENTS TO VARIOUS BODIES, GROUPS AND PANELS 2017/18

1. PURPOSE OF THE REPORT

To request the Council to consider the appointment of representatives to serve on various Bodies, Groups and Panels.

2. BACKGROUND

The Council Constitution provides the Council with authority to appoint representatives to Outside Bodies. The Council is asked to consider nominations to the Outside Bodies, and Blackburn with Darwen Borough Council Partnership Bodies.

3. APPOINTMENTS

Outside Bodies

At the Annual Council Meeting on 21st June 2001 the following was approved in relation to Outside Body appointments (Minute 13 refers):-

This Council believes that when considering appointments to Outside Bodies it should seek to reflect the political composition of the Council as closely as possible.

It therefore resolves that, with the exclusion of those nominations made by reference to political office (that is Leader of the Council, Leaders of the Political Groups, Executive Board Members, Chairs of Committees or their nominees) or to the Mayor and Deputy, appointments be made on the following basis:-

1. When there is only one representative it is from the controlling Group.

2. Where there is more than one representative the places are allocated in the same proportion as the political composition of the Council.

3. That discussions take place between representatives of all political Groups at the start of the Council Year to agree the allocation of seats in accordance with (1) and (2).

4. When seats become vacant during the Council Year, the political party allocated the seat in (3) has the right to nominate a replacement.

As there is a by-election on the 8th June for the Higher Croft Ward, the proportionality calculations will be applied to the Outside Bodies list after that date and after the annual process outlined in Paragraph 4.1. When the Outside Bodies list has been agreed it will be submitted to the next available Council meeting.

Blackburn with Darwen Borough Council Partnership Bodies

Members of the Council serve on various partnership bodies. Appointments to these may be determined by the constitution of the body concerned, or have been made previously by the Executive or an appropriate Committee of the Council.

If the political Group nominations are available they will be circulated before the Annual Meeting.

Appeals and other bodies

The Council is asked to establish a panel of fifteen members to form an Appeals Panel to consider, in accordance with the Constitution and any statutory provisions:

- Discretionary Grant, School and Post School Transport Appeals
- Social Services Review Panel
- Any other Appeals as appropriate

If the Political Group nominations are available they will be circulated before the Annual Meeting.

4. <u>RECOMMENDATIONS</u>

4.1 That in the first instance, (as is usual practice) each of the organisations listed on the outside bodies, and partnership bodies list is contacted to establish;

That their Terms Of Reference / Articles Of Association have not changed and still require Council Representation in the same capacity, for the same tenure, and what added value will be mutually brought by such engagement. Subject to which;

4.2 That following the process outlined in Section 3 above, nominations will be confirmed as the Council's representatives to serve until the end of the current Municipal Year; or if a longer period of office is shown, until that date; unless during the Municipal Year the Leader amends the appointments to take account of changed requirements.

4.3 That fifteen Members be appointed to serve on the panel of Members to deal with appeals.

(Note: As is usual practice, the decisions on representation can be delegated to the Group Leaders to agree the appointments. The nominations to the Lancashire Combined Fire Authority will need to be agreed so that appointments can be affected by the Clerk to the Authority as soon as possible).

3. CONSTITUTION UPDATE

The Constitution is a key document setting out the governance framework of the Council. From time to time the constitution needs to be updated to reflect changes in legislation, resolutions passed by Council, portfolio changes made by the Leader, and changes made to the Council management structure and delegations. The Constitution was last updated in December 2016.

Members will note that there have been changes to the Chief Officer structure of the Council approved through the Chief Officers Employment Committee and as appropriate via the partnership agreement with Capita which required amendments to Part 3, Section 16 Officer Scheme of Delegation. Those changes are now reflected in the revised Constitution.

During the latest review of the Constitution it was also identified that a section on the Common Seal of the Council should be included in Article 14 and this is now an addition as 14.05.

5. CONSTITUTION POLICY IMPLICATIONS

Constitutions set out the governance framework for local authorities, which provide the foundations for any local authority that aspires to be effective, progressive and successful.

1. PURPOSE OF THE REPORT

To suggest revisions to the Local Government Boundary Commission for England (LGBCE) draft Warding arrangements for Blackburn with Darwen Borough Council, which are out to consultation until 19th June 2017.

2. RECOMMENDATIONS

Overall the Local Government Boundary Commission have agreed with most of the suggestions made by the Council in its formal submission in January. However, whilst the Council supports the majority of the proposals, there are some areas where further changes are suggested as outlined below. It is recommended that Council:

FURTHER CONSIDERATIONS FOR THE COMMISSION

1. Central

We support the Local Government Boundary Commission reviews draft recommendations but would like the Commission to consider a name change to <u>Blackburn Central</u>.

2. Ewood/Blackburn South boundary.

The boundary commission have referred to the fact that the Heights Free School is situated off Heys Lane and should therefore be in Ewood ward as this is the residential area nearest to it. This fails to recognise that The Heights Free School provides alternative education for young people at risk of not reaching their potential and does not specifically serve local residents.

It would appear that the Heights Free School and Eden School have been considered as schools supporting the Ewood Ward – We would ask the Commission take into account that both schools are specialist schools that support the whole of the borough not just the Ewood Ward. Heys Lane is the natural Boundary between these wards, with significant future planning activity coming forward as we speak.

3. Ewood / Mill Hill and Moorgate / Livesey with Pleasington

Ewood/Livesey with Pleasington boundary: The draft recommendations place both sides of Gib Lane into Ewood (at present both sides are in Meadowhead). We would ask that the Commission take into account that a new housing development is being constructed immediately behind the properties on the west of Gib Lane and that some of its access will be from Gib Lane. It is therefore more logical for the West side of Gib Lane to be moved into Livesey with Pleasington. We will provide photographs of some of the existing new developments.

4. Darwen Rural

Notwithstanding the Commissions draft recommendations refer to Park Street, which should actually refer to Park Road – we support the Local Government Boundary Commission reviews draft geographical recommendations. However we wish to suggest a change of name to the 'Darwen Rural' ward: Feedback from residents suggests that the ward would be better suited to a name making less reference to any local towns. People in Edgworth, Belmont and Chapeltown consider themselves most closely associated with Bolton, whilst people living in the southern part of the current Whitehall ward do not consider themselves to be rural. A more appropriate name would be 'West Pennine'. This reflects the geographical situation of the ward, encompassing the largest part of the locally important landscape area the West Pennine Moors'.

5. Billinge and Beardwood / Shear Brow and Corporation Park

Shear Brow/Billinge and Beardwood. The BwD proposal recommended that a straight line was drawn along Revidge Road. This was to correct the current boundary which cuts in and out along the length of the highway. This was arrived at by using the Commissions statutory criteria of

- o Delivering electoral equality for local voters,
- o Interests and identities of local communities, and
- Effective and convenient local government.

The Boundary Commission proposal effectively argues for the current boundary line to be retained. We wish the Commission to consider the following two points: We cannot see the rationale for properties between (approx.) 401 Revidge Road and 539 Revidge Road to be placed into Beardwood and Billinge, whilst the other properties on the north side of Revidge Road are claimed to fit better with Shear Brow and Revidge. Secondly - the BwD proposal has better equality of electors than the Boundary Commission draft recommendation, which has Billinge and Beardwood at -9%.

Audley and Queens Park

6. Subject to agreeing the above recommendations, authorise the Chief Executive to formally submit the proposal on Council Warding arrangements from May 2018 to the Local Government Boundary Commission for England for their inclusion as early as possible in the next round of consultation.

3. COUNCIL 2017 WARDING PROPOSAL

Blackburn with Darwen Borough Council currently has 64 elected Members in 23 wards. Members will be aware that following the agreement at Council on 6th October 2016 the Boundary Commission formally confirmed the size of Blackburn with Darwen Borough Council to be 51 Councillors for 17 Wards by 2018 to ensure appropriate levels of Governance, Scrutiny and Community Leadership which also allows for the Authority to continue to elect its Members by thirds.

Using the Boundary Commissions guidance to develop a new Warding proposal for the Borough, several factors were taken into consideration, primarily the statutory criteria of;

- Delivering electoral equality for local voters this means ensuring that each councillor represents roughly the same number of voters so that the value of your vote is the same regardless of where you live in the local authority area.
- Interests and identities of local communities this means establishing electoral arrangements which, as far as possible, avoid splitting local ties and where boundaries are easily identifiable.

• Effective and convenient local government – this means ensuring that the wards can be represented effectively by their elected representative(s) and that the new electoral arrangements as a whole, including both the council size decision and warding arrangements, allow the local authority to conduct its business effectively.

4. BACKGROUND

It should be noted that the Council cannot take its own decisions on size or warding arrangements and must submit its proposals to the LGBCE at every stage. The LGBCE will consider and determine the proposals based on its own assessment of relevant factors.

At every stage the LGBCE will consult widely seeking the views of a range of stakeholders.

Key messages for the public and individuals - How to have your say:

Please note the deadline for submissions on the draft recommendations is 19th June 2017.

An electoral review is a consultative process. You, and your community, can influence the outcome. The commission have an open mind about adopting proposals from groups or individuals that are supported by evidence and complement the statutory criteria.

The commission are only able to consider evidence that is made to them in writing as all decisions are taken by formal meetings of the whole commission. The best evidence includes the reasons why you agree with our proposals or why you disagree with them. If you do not think their proposals are right for our area, we would welcome alternative suggestions for boundaries that meet their criteria. There are several ways in which you can keep up to date with the progress of the review and to have your say:

Online

You can keep track of the electoral review for your area through our website at www.lgbce.org.uk. The commission have set up a dedicated web page for each review where you will find details of its timetable, our reports, maps, proposals and guidance. You can comment on their proposals directly through their website or by emailing: reviews@lgbce.org.uk They also publish all the submissions they receive so you can see what kind of evidence they relied on to make our decisions.

Interactive consultation portal

The portal allows you to view and interact with our maps as well as comment on their proposals directly. By logging on to <u>www.consultation.lgbce.org.uk</u> you will be able to view their proposals down to street level, draw your own pattern of wards or annotate the maps to tell them about the nature of community interests and identities in your area.

5. POLICY IMPLICATIONS

Council are asked to note the direction of travel from both this Warding proposal and the background papers submitted to and agreed by Council Forum in October 2016 and January 2017, acknowledging that a detailed review will be undertaken over the next 12 months to redesign a political structure that will be fit for purpose and fit for future to best serve the people of Blackburn with Darwen.

6. FINANCIAL IMPLICATIONS

Effectively supporting fewer yet larger Wards will subject to the detailed review outlined in "Policy implications" to deliver strong effective local government.

7. LEGAL IMPLICATIONS

1. The LGBCE is required to comply with certain rules when conducting a Review. Local Democracy, Economic Development and Construction Act 2009, section 56 requires the LGBCE to conduct a Review of principal local authorities from time to time and recommend whether a change should be made to the "electoral arrangements" meaning:

- the total number of Members to be elected to the Council ('Council size');

- the number and boundaries of electoral areas for the purposes of the election of Councillors;

- the number of councillors to be returned by any electoral area (ward) in that area

- the name of any electoral area.

In making recommendations, under Schedule 2 of the Act the LGBCE must have regard to:

- the need to secure equality of representation;
- the need to reflect the identities and interests of local communities; and
- the need to secure effective and convenient local government.

2. Any resolutions regarding the scheme of elections must be in accordance with the Part 2 of the Local Government and Public Involvement in Health Act 2007.

3. The review of Members' allowances will need to be undertaken by the Independent Remuneration Panel and in accordance with the Local Authorities (Members' Allowances) (England) Regulations 2003.

8. RESOURCE IMPLICATIONS

A small team of Officers continues to be convened when required, to support the various stages and requirements of the Review and its consultations, ensuring compliance with the timetable outlined by the Local Government Boundary Commission England.

9. EQUALITY IMPLICATIONS

As an integral element to the process, Equality Impact Assessments will be undertaken at various stages of the Review and its consultations.

10. CONSULTATIONS

21st July 2016 the Commission consulted with all Members of the Council on the Review process. From 22nd November – 30th January 2017 the Commission carried out the first stages of a review. Currently they are in the process of a public consultation on new draft warding arrangements, from 11th April – 19th June 2017. A final decision by the Commission and recommendation to Government will be made on 5th September 2017, following which an Order will be Laid before Parliament in October 2017 for implementation in the all-out elections of May 2018.
