ELECTION RECHARGES FOR PARISH AND TOWN COUNCILS

1. PURPOSE

The purpose of this report is to inform members and seek approval of the proposed basis of recharging parish and town councils for the costs incurred by the Borough Council in running contested elections of their behalf.

2. RECOMMENDATIONS

Members approve the recharging of all parish and town councils in the Borough for the costs incurred by the Council in running all future contested elections on their behalf.

3. KEY ISSUES

The Council does not currently recharge parish councils for the cost of running contested elections. Many councils do recharge both in Lancashire and elsewhere.

Section 36(5) of the Representation of People Act 1983 allows a Council if it so requires to recharge parish/ town councils for the expenditure properly incurred in running elections on their behalf.

There is no standard parish council election cost as there are many variables ranging from the size of the electorate to the cost of hiring a polling station. The estimated costs for two parish councils with a differing electorate are attached at Appendix 1 as an example of the proposed basis for recharging.

If the Council does decide to levy a charge, then where there is a combined Borough or European and parish/town council election, the charges for poll card delivery, polling station staff and polling station hire charges will all be shared 50/50.

The Borough Council will continue to meet the costs of uncontested elections. The costs incurred would be nominal (approximately £200 to £300) in most cases.
