## 38 Minutes

Following a debate on proportionality and the timing of appointments to Outside Bodies, Council received and confirmed the minutes of the Council Forum meeting on 24<sup>th</sup> June and Extraordinary meetings of Council on 20<sup>th</sup> July and 14<sup>th</sup> September 2010.

## 40 Mayoral communications

The Deputy Mayor reported that the Mayor was recovering well from her current illness and hoped that she would be able to resume her duties in the foreseeable future and that best wishes had been passed onto her after the last Council meeting.

In the Mayors absence, the Deputy Mayor reported she had carried out a wide range of engagements including speaking to a group of German students on an exchange visit with St Wilfred's school, her first Citizenship ceremony earlier that week where some 54 new citizens were made citizens of the United Kingdom and that she had a pleasant day walking the new heritage trail in Corporation Park and even helped launch a new £150,000 bus at Whalley Abbey.

She concluded by informing Members that the Duke of Lancaster's Regiment would be holding a Cathedral Service and Homecoming Parade on the 1<sup>st</sup> December, with Members being invited to attend the service in the Cathedral at 12 noon and then support the parade through the Town Centre after. She hoped to see as many Councillors there as is possible to show their appreciation and respect for the job the soldiers had done whilst serving in Afghanistan and to remember those of the Regiment who have sadly lost their lives during the conflict.

## 43 Motions Submitted under Procedure Rule 12.

Council received and considered the following Notices of Motion submitted under Procedure Rule 12 which had been moved by Councillor David Foster and seconded by Councillor Simon Huggill.

#### Motion 1

#### Resolution 1.

This Council reaffirms its commitment to Neighbourhood working. In particular it recognises the good work done by Neighbourhood Boards and remains committed to their continued existence and development.

#### Resolution 2.

This Council acknowledges the success of the installation of Alley gates within the Borough in reducing crime, antisocial behaviour and litter, whilst improving the communities' sense of safety. This Council

therefore resolves that, as a minimum, the Alley gate scheme will continue at its present budgeted level.

#### Resolution 3.

This Council resolves that after 5 years of uncertainty, the residents of Harwood Street in Darwen will have the promised facelifts to their properties, and that there will be no threats of demolition to their homes.

#### Resolution 4.

This Council resolves to maintain weekly Household waste collections.

#### Resolution 5.

This Council believes that Community control is preferable to Council control of our community Centres.

#### Resolution 6.

This Council resolves that Darwen Library Theatre should be subject to continuing investment not cutback.

#### Resolution 7.

Robin Bank in Darwen has been the subject of some unusual visionary schemes. Although the bid for PFI funding was unsuccessful, this Council reaffirms its commitment to the delivery of a "Care village" scheme on this site, and that the work to deliver this, that has been undertaken by the previous administration, should be taken forward with all due speed.

Following a debate, Councillor Andy Kay moved an amendment to the Motion, Seconded by Councillor Jan-Virmani:

This council reaffirms its commitment to give the same, or better, level of grant funding, this council will: -

- Provide an alley gate programme
- Give a fair decision, very soon, for the residents of Harwood Street Darwen, a decision ducked by the ex-Executive Member for Housing.
- Provide weekly household waste collections
- Support community organisations to explore the possibilities for them to manage community centres
- Maintain the Darwen Library Theatre
- Explore all possibilities for the care of our residents, both young and old.

Following a further debate, there followed a vote on the original motion

**RESOLVED** – That the original motion be lost.

The Council moved to a vote on the amended motion.

RESOLVED - That the amendment be carried.

#### Motion 2

This Council resolves to move back to the committee system of governance.

Proposed by Councillor Colin Rigby Seconded by Councillor Michael Lee

On the Motion 2 Councillor Kay asked for legal opinion on the legality of the motion as it stood, as it did not appear practical or implementable under the Councils Constitution.

Councillor Lee requested that the motion be altered. At which point is was explained that a revision required consent of the meeting which was not received.

RESOLVED - That the motion be lost.
