SUBJECT: Adoption Service Six Monthly Report - 1 October 2015 - 31 March 2016

1. EXECUTIVE SUMMARY

To provide information on the management and performance of the Local Authority's Adoption Service.

2. RECOMMENDATIONS

3. BACKGROUND

Standard 25.6 of the National Minimum Standards for Adoption requires the Local Authority Adoption Agency to produce a six monthly report to be received by the Council's Executive.

The standard states that the Council's Executive:

- a. Receive written reports on the management, outcomes and financial state of the agency every 6 months;
- b. Monitor the management and outcomes of the services in order to satisfy themselves that the agency is effective and is achieving good outcomes for children and/or service users;
- c. Satisfy themselves that the agency is complying with the conditions of registration.

The report has been written to address the issues identified above, and it will be taken into account by OFSTED when inspecting the Service.

The report summarises the performance of the Adoption Service for the six month period from 1st October 2015 to 31st September 2016 and provides an overview of the work of the Service for this period.

4. KEY ISSUES

- 1. The regionalisation of adoption has continued to develop. The Project Team reported its findings from their research into how adoption services are being delivered currently across the Regional Adoption Agency (RAA) to the Project Board. A decision has been made to develop a hub and spoke model though there are legal issues which have yet to be resolved. The team are holding further workshops to begin the process of working towards implementation of the plan. Despite the uncertainty surrounding adoption currently the team has remained motivated and enthusiastic and have participated fully in workshops and meetings to assist the Project Team.
- 2. There has been a small increase in the number of Should Be Placed for Adoption (SHOBPA) decisions in the last six months following a period when numbers have been low. There are currently 15 children waiting to be placed which is a reduction from previous years. The majority of these have placements identified. 11 children were placed for adoption in 9 placements during the six month period, 27 over the full year compared to 35 the previous year. 16 Adoption Orders were made during this period making a total of 30 for the year, again a significant reduction.

The reduction in the number of children waiting has been disheartening for many adopters as an increasing number are now waiting 12 months or more to be matched with a child. The reduction in the number of children needing adoption placements has affected the number of prospective adopters coming forward to be assessed although there has been a slight upturn in the last quarter. There are 20 adopters waiting to be matched, 3 with matches identified. The service is now delivering training on 'Managing the Wait' which recognises the emotional impact of waiting for long periods post approval.

3. The Post Adoption Support team has 42 open cases, 12 of which are open for assessment and support. The Post Adoption Support Fund has improved access to therapeutic intervention for adopted children and the service has taken full advantage of the funding available. Scorecard performance requires further improvement particularly in relation to achieving the 121 day target timescale between Placement Order and matching. In the last 6 months 6 children exceeded this timescale for reasons beyond the control of the service. The service continues to match 'hard to place' children.
