1 ELECTION OF CHAIR AND VICE CHAIR

2 APOLOGIES

3 MINUTES OF THE MEETING HELD ON 12TH JULY 2010

AGREED – That the minutes of the meeting held on 12th July 2010 be agreed as a correct record.

4 Implications and Impact of the recent Comprehensive Spending Review:

A presentation was submitted by Councillor Mohammed Khan, Deputy Leader at Blackburn with Darwen Borough Council and Neil Matthewman, Managing Director Health Services at Blackburn with Darwen Care Trust Plus, outlining the impact of public sector cuts and what they would mean for Blackburn with Darwen as follows:

- 500,000 public sector jobs likely to go
- Equivalent loss in private sector jobs
- 28% four-year cut for local government with biggest chunk next year
- £7bn in additional welfare budget cuts
- 40% cut in Building Schools for the Future Projects
- Police funding cut by 16% over 4 years

Councillor Khan advised that this would mean a cut of £48m over the next four years, with a cut of £29m next year.

The challenges for health were highlighted as follows:

- Small increase in NHS funding which was not enough to meet rising cost and increased patient demand
- NHS faced a £15-20bn shortfall nationally to be met by 2013/14

- All NHS organisations expected to improve efficiency by at least 4% per annum
- Planned 40%+ management cost reduction by 2013 and major NHS reorganisation was underway
- The Care Trust would find out how much funding it would received for 2011/12 late December 2010

Further discussion took place in relation to the spending review with representatives from the following advising the LSP Board:

The Board was also advised that residents would be kept informed via meetings of residents, staff, voluntary, faith and community groups, Ward Councillor surgeries, publication of the Shuttle and local media, the Council and other websites. The views of local residents and communities would also be sought.
