1 APOLOGIES

2 MINUTES OF THE MEETING HELD ON 15TH NOVEMBER 2010

AGREED – That the minutes of the meeting held on 15th November 2010 be agreed as a correct record subject to the addition of Gladys Rhodes White in attendance.

3 JESSICA (EVERGREEN) INITIATIVE

Brian Bailey submitted a report updating and providing background information to the LSP Board, of the Jessica Initiative (Joint European Support for Sustainable Investment in City Areas) which was a European programme designed to create a "revolving door" of sustainable loans to fund business development and economic and transport infrastructure.

In the era of deficit reduction, the trend was to take the burden off the public purse and to encourage more sustainable ways to fund future growth and job creation. The private sector was being encouraged to play a greater role by incentivising development through joint ventures and partnerships via the tax system.

Jessica was the name of the EU programme which matched ERDF funds with UK domestic funds and public assets to create regional funds from which loans could be drawn down. Evergreen was the name of the North West Investment Fund which would deliver the programme in this region. It had followed a competitive process which had been won by a bid lead by the GM Pension Fund (GMPF) and was expected to go live in April 2011.

Brian outlined to the LSP Board how Jessica and Evergreen would work and be managed, how projects would be selected, the strong strategic case and process for joining, timescales and next steps.

AGREED – That the report be noted.

4 UPDATE ON THE RESEARCH ON LOCAL ECONOMIC RESILIENCE BY THE CENTRE FOR LOCAL ECONOMIC STRATEGIES (CLES)

Neil McInroy, Chief Executive, Centre for Local Economic Strategies (CLES) presented to the LSP Board on the matter of 'Understanding the Place Resilience of Blackburn with Darwen'.

CLES had been asked by Blackburn with Darwen to contribute to the development of the 2030 vision by looking at the current resilience of place. This had entailed specifically concentrating on understanding the strategic relationships that existed within the public, commercial and social sectors. The findings had been based on the immediate past, but would further reflect on cuts in final work.

Neil referred to the measures of resilience and provided details in relation to them -

Measures 1-6 – size of economies and strengths of the relationships within the local economic territory e.g. public – commercial, commercial – social, public – social.

Measures 7-10 — awareness of and action taken to deal with the external factors that have an influence on the local economic territory.

Neil also advised the LSP Board as to why the resilience model was useful, the methodology used, key findings, conclusions, recommendations and that a Social Network Analysis (SNA) of relationships and greater focus on impact of cuts and change would follow.

Members were informed that a report would be circulated and made available for comments and then redrafted. A final presentation and dissemination workshop would also be held.

RESOLVED – That the presentation be noted.

5 OPEN DISCUSSION ABOUT THE FUNDING SETTLEMENTS 2011

A discussion took place in relation to the funding settlements for 2011 in which it was highlighted that as a result of decisions made at the extraordinary meeting of the Council held on 6th January 2011, over 1,750 staff positions at Blackburn with Darwen Borough Council had been placed 'at risk'. 35% savings would have to be achieved over a period of 4 years, with a saving of £28m to be achieved in the first year. Consideration was being given to options to fill the financial gaps.

Going forward the Local Authority budget would still be £350m, with priority being given to the refocusing of spending. The emphasis was on attempting to protect frontline services.

It was highlighted that Care Trust + efficiency savings would result in the decommissioning of low level services and that a consistent approach to commissioning was necessary to avoid duplication. Cuts in welfare benefits e.g. Education Maintenance Allowance were also highlighted. The importance and relevance of the third sector was also highlighted.
