The case will then be independently assessed by a Planning Inspector. The enclosed leaflet provides further details of the appeals process.

If the application is submitted by an agent, all correspondence is sent to them. If there is no agent, all correspondence is sent direct to the applicant.

If the application is to be determined by the Planning & Highways Committee, members of the Committee will visit the site, and receive a full report about the application, including details of any comments received, to enable them to reach a decision. You will be able to attend the committee meeting and under certain circumstances be able to speak at the meeting. Should

you decide you would like to speak at committee, please complete and return a 'request to speak form' by 12 noon the day before the committee date.

## Appealing to the Secretary of State for Communities and Local Government for a Decision

If you are asked for an 'extension of time', and you do not agree, you have the option of appealing to the Secretary of State for Communities and Local Government for a Decision.

However, once an appeal for 'non-determination' is made, the Council will take no further action on the application, so you might want to consider if the appeal will delay the decision further or whether it would be quicker to let the Council make a decision.
