I wish to remove 2 conifers in my garden which have become too tall. One is 6 feet from the front corner of the house and about 12 foot tall, and other is 10 feet from the back of the garage and is over 15 foot tall. This one is growing at over 1 foot a year and is now unmanageable. I will replace the one at the front of the house with an attractive climber what can grow over the wall that is already in position. I do not wish to replace the one at the back of the house with another tree. It cannot be seen from either the house or the road.
