The existing clearing is quite wide and screened from the road by vegetation. The access would connect to the A666, where 50mph speed is often exceeded. The proposed access would need to ensure clear visibility to assist vehicles exiting the site and also vehicles already on the highway. The scheme drawing indicates a turning area. To satisfy the authority, the applicant would be required to demonstrate vehicles turning through submission of a tracking model and a servicing plan, i.e. frequency of movement, type of vehicles etc. Likewise visibility splays need to be provided. Subject to the above being satisfied we would be minded to support the proposal. The proposal is, therefore, broadly compliant with Policy 10 of the Council's Local Plan Part 2, which relates to Accessibility and Transport, ensuring an application should be supported. The above comments are based on the information you have provided and will not prejudice the formal submission and determination of any subsequent planning application.
