# 9. Growth Agenda

The Committee received a presentation on the Council's Growth Agenda from the Director of Planning & Prosperity, focusing on; Driving economic growth, Creating more jobs with more residents in work and major capital schemes and develop a scheme pipeline to sustain growth.

Members where reminded that at the January and March 2016 Committee meetings, the Committee had received 2 detailed presentations on the Council's Growth Agenda which had been included with the Agenda papers for Members information.

The director informed the Committee of the Council's growth forecast for the borough, including revenue growth and how this will be achieved. In particular around housing sites in both Blackburn and Darwen.

Members were also provided with a breakdown of commercial and industrial properties/sites in the borough that had the potential for both new business and expansion to business.

Members were then provided with a progress update on a number of town centre projects in the borough and development sites;

### Blackburn

#### Cathedral Quarter and Bus Station

- Construction completed some snagging still underway
- Hotel trading very well top in region
- First office tenants, Govnet moved in. Capita and local insurance broker to follow once legals complete. Progressing other enquiries
- Cathedral Clergy and staff now living in new residences
- Café Northcote opened in Cathedral Court and trading well
- Premier Inn restaurant unit let subject to completion of contract and strong interest in large unit under office
- Small café/retail unit back on the market
- Bus Station completed and open

## Blakey Moor Townscape Heritage Project

- £3.5 million project for Blakey Moor Area
- Key projects including Blakey Moor Terrace, public realm in front of KGH, KGH frontage, Baroque, Northgate and Lord Street West properties
- · Development phase of Delivery started
- On site 2017 with key projects and public realm
- Consultation starts with property owners in October

#### Darwen

### 3 day Markets site

- Programme of market traders relocation underway and planned completion before Christmas trading period 2016
- Demolition February/March 2017
- Building to be secured and tidied with hoardings and visuals once empty
- Soft market testing underway to review potential commercial interest
- Darwen Town Centre Partnership Board to lead on further consultation

 14 bedroom new hotel development on key corner site with ground floor retail
