SUBJECT: Member training and development.

1. PURPOSE OF THE REPORT

To update the Committee regarding the compulsory Child Sexual Exploitation training undertaken by elected Members in 2014/15.

3. RATIONALE

The role of the Standards Committee includes the ability to provide an assurance that elected Members receive apposite training and development to enable Members to maintain high standards of accountability, conduct, decision making and governance by Councillors and coopted members. 4. BACKGROUND

<u>Child Sexual Exploitation (CSE) 10th, 12th November 2014 and 24th June 2015.</u>

Members will be aware that on Thursday 2nd October 2014 the Standards Committee endorsed the recommendation from the Monitoring Officer and the Director of Children's Services that CSE training be mandatory along with a recommendation arising from an Extraordinary meeting of Children and Young People Overview and Scrutiny Committee that the training is made available to ALL Members.
