# SUBJECT: King George's Hall Pantomime contract

#### 1. DECISION

To appoint Shone Productions to produce King George's Hall's Christmas Pantomime on a four year contract with no option to extend.

### 2. REASON FOR DECISION

The tender specification for the production was advertised on the Chest procurement system.

Four submissions were received in response to the Invitation to Tender. These were evaluated on a 40% price and 60% quality basis. Scores from the applications were supported by visits to view examples of their 2019 productions to ensure that a quality production could be delivered. See price and quality scores in the table below:

| Contractor           | Price 40 %<br>Score | Quality 60 %<br>Score | O/A % Score |
|----------------------|---------------------|-----------------------|-------------|
| Bidder A             | 35%                 | 27.5%                 | 62.5%       |
| Bidder B             | 10%                 | 30%                   | 40%         |
| Bidder C             | 28%                 | 47.5                  | 75.5%       |
| Shone<br>Productions | 33%                 | 55%                   | 88%         |

Following an evaluation of the returned tenders, Shone Productions were selected as the successful bidder.

#### 3. BACKGROUND

King George's Hall's Christmas Pantomime has been a feature of the Blackburn events calendar for 25 years. In 2018, a procurement review advised that due to the value of the contract, the contract should be re-procured via a tender process. The current Pantomime production company was granted a one-year extension in 2019, to enable the KGH management team to research other available products during the 2019 pantomime season to help shape the requirements of the tender. A tender was advertised on the Chest procurement system, as a four-year contract with no option to extend, with the contract commencing on the 2020 pantomime run.
