# 52 Welcome and Apologies

The Chief Executive read out the notice convening the meeting and the Mayor advised how the remote meeting would operate.

# 53 Minutes Of The Previous Meeting

The Minutes of the Finance Council meeting held on 1<sup>st</sup> March 2021 were agreed as a correct record.

# 54 <u>Declarations of Interest</u>

No Declarations of Interest were received.

### 55 Mayoral Communications

The Mayor noted the first anniversary of the Covid-19 lockdown, and advised that his thoughts were with all those affected, advising that nominations for the Mayoral Awards could be made for anyone who had gone above and beyond in responding to the pandemic.

The Mayor also confirmed his chosen Mayoral Charities for 2021/22 which were the East Lancs Scouts, East Lancs Guides, Derian House and the East Lancs Hospice,

The Mayor concluded by thanking all those who had made it possible to run virtual meetings during the Municipal Year.

### 56 Council Forum

The Chief Executive reported that no questions had been received under Procedure Rule 12.

### 57 Motions

The Chief Executive reported that no Motions had been received under Procedure Rule 10.

### 58 Covid-19 Pandemic- One Year On

A report was submitted which provided an overview of the key highlights of the Council's response to the COVID-19 pandemic over the last 12 months.

Since the first case in Blackburn with Darwen last March, the Pandemic had seen more than 17,500 positive cases of COVID in the Borough; the highest cumulative rate for any local Authority in the Country.

The report detailed the Council's role as Civic Leader, and the response including, Governance, Leadership and Partnership, Adapting Services, the Testing Programme, Support for Residents, Businesses and Workplaces, the Vaccination Programme, as well as a look ahead to the 'New Normal'.

**RESOLVED** – That the report be noted.

# 59 Updates from Other Committees

The Chairs of the Standards Committee, PEOPLE, PLACE and Policy and Corporate Resources Overview and Scrutiny Committees provided updates on the recent work of their respective Committees.

The Chair of the Standards Committee, Councillor Saima Afzal, reported that the Committee on Standards in Public Life made a number of recommendations in their January 2019 report on local government ethical practice standards. In that report, they identified some best recommendations which represented a benchmark for ethical practice and which they expected any local authority to implement. The Standards Committee reviewed the recommendations made and as set out in the Appendices to the report considered these, against the current Code of Conduct and Constitution and also considered the option of adopting the latest Model Code of Conduct produced by the LGA.

After considering the options the Standards Committee unanimously recommended to the Council Forum

 Adopt the 15 best practice recommendations which the Committee on Standards in Public Life consider represent a benchmark for ethical practice and which they expect any local authority should implement (Appendix A). Then subject to 1) above agree the Full Council:

- 2) Update the local Code of Conduct and update the local Arrangements for dealing with Complaints about the Code of Conduct for Members to reflect the Committee on Standards in Public Life best practice recommendations as set out in both documents referenced in Appendix B;
- 3) That Best Practice Recommendation 5 continue to apply annually for administrative effectiveness and efficiency.
- 4) That Best Practice Recommendation 15 be applied on an annual basis with Group Leaders.

**RESOLVED** – That the recommendations from the Standards Committee be approved and that the report and updates from the Chairs of the PEOPLE, PLACE and Policy and Corporate Resources Overview and Scrutiny Committee be noted.

# 60 Reports of Executive Members with Portfolios

The Leader and Executive Members presented their reports, providing updates as appropriate.

During discussion of the reports, the use of the Chat function in MS Teams was discussed, and Members were advised that at the Standards Committee the night before, it had been agreed that Officers produce a protocol for correct use of the function.

Members of the Executive Board cannot serve on any Overview and Scrutiny Committee.

Political parties make nominations to the Committees listed in 2 above. Places are allocated in line with the Local Government and Housing Act 1989 (ss.15-17) as regards proportionality. Political Group nominations will be circulated prior to the meeting of Annual Council.

### THE MAYORALTY 2021/22

### 1. PURPOSE

To consider arrangements for the nominations to office of Mayor and Deputy Mayor.

### 2. RECOMMENDATIONS

The Annual Council:

- 1. Confirms the appointment of Councillor Derek Hardman as Mayor of the Borough for 2021/22; and
- 2. Confirms that in accordance with the rotation arrangements agreed at Annual Council in May 2018 that it is the Labour Group's turn to nominate the Deputy Mayor for 2021/22 and notes the appointment of Councillor Suleman Khonat as Deputy Mayor for 2021/2022 earlier in the meeting.
- 3. Notes that a report on the future rotation agreement for the Mayoralty from 2023/2024 onwards will be submitted during the new Municipal Year.

### 3. BACKGROUND

Annual Council formally appoints Members of the Council to the office of Mayor and Deputy Mayor for the forthcoming Municipal year. The Member appointed to the position of Deputy Mayor is normally appointed to the office of Mayor in the following year.

At previous meetings of the Council it has been agreed that the rotation of the nomination to the Office of Mayor between the political groups be based on proportionality of the Council, and an agreed rotation would be set for the next five years.

Annual Council in May 2018 determined the rotation arrangements for 2018/19 onwards. The rotation for the next 5 years was determined as follows:

2018/19 Labour 2019/20 Labour 2020/21 Labour 2021/22 Conservative

### 2022/23 Labour

A report on the appointment of the Mayor is submitted to the Annual Council each year, and in the event that the proportionality of the Council changes going forward in a way that would affect the nomination of Mayor for a particular year, a report on this matter would be submitted for Council's consideration.

In accordance with the above, it would be for the Conservative Group to nominate the Mayor for 2021/2022, who in line with usual practice would be the serving Deputy Mayor, which in this case is Councillor Derek Hardman.

As referred to above, it is also the turn of the Labour Group to nominate the Deputy Mayor for 2021/22.

### APPOINTMENTS TO VARIOUS BODIES, GROUPS AND PANELS 2021/22

# 1. PURPOSE OF THE REPORT

To request the Council to consider the appointment of representatives to serve on various Bodies, Groups and Panels.

# 2. BACKGROUND

The Council Constitution provides the Council with authority to appoint representatives to Outside Bodies. The Council is asked to consider nominations to the Outside Bodies, and Blackburn with Darwen Borough Council Partnership Bodies.

# 3. APPOINTMENTS

## **Outside Bodies**

At the Annual Council Meeting on 21<sup>st</sup> June 2001 the following was approved in relation to Outside Body appointments (Minute 13 refers):-

This Council believes that when considering appointments to Outside Bodies it should seek to reflect the political composition of the Council as closely as possible.

It therefore resolves that, with the exclusion of those nominations made by reference to political office (that is Leader of the Council, Leaders of the Political Groups, Executive Board Members, Chairs of Committees or their nominees) or to the Mayor and Deputy Mayor, appointments be made on the following basis:-

- 1. When there is only one representative it is from the controlling Group.
- 2. Where there is more than one representative the places are allocated in the same proportion as the political composition of the Council.
- 3. That discussions take place between representatives of all political Groups at the start of the Council Year to agree the allocation of seats in accordance with (1) and (2).

4. When seats become vacant during the Council Year, the political party allocated the seat in (3) has the right to nominate a replacement.

As referenced below in the recommendations when the Outside Bodies list has been agreed it will be submitted to the next available Council meeting.

### Blackburn with Darwen Borough Council Partnership Bodies

Members of the Council serve on various partnership bodies. Appointments to these may be determined by the constitution of the body concerned, or have been made previously by the Executive or an appropriate Committee of the Council.

If the political Group nominations are available they will be circulated before the Annual Meeting.

# Appeals and other bodies

The Council is asked to establish a panel of fifteen members to form an Appeals Panel to consider, in accordance with the Constitution and any statutory provisions:

- Discretionary Grant, School and Post School Transport Appeals
- Social Services Review Panel
- Any other Appeals as appropriate

If the Political Group nominations are available they will be circulated before the Annual Meeting.

### 4. RECOMMENDATIONS

4.1 That in the first instance, (as is usual practice) each of the organisations listed on the outside bodies, and partnership bodies list is contacted to establish;

That their Terms Of Reference / Articles Of Association have not changed and still require Council Representation in the same capacity, for the same tenure, and what added value will be mutually brought by such engagement. Subject to which:

- 4.2 That following the process outlined in Section 3 above, nominations will be confirmed as the Council's representatives to serve until the end of the current Municipal Year; or if a longer period of office is shown, until that date; unless during the Municipal Year the Leader amends the appointments to take account of changed requirements.
- 4.3 That fifteen Members be appointed to serve on the panel of Members to deal with appeals.

(Note: As is usual practice, the decisions on representation can be delegated to the Group Leaders to agree the appointments. The nominations to the Lancashire Combined Fire Authority will need to be agreed so that appointments can be affected by the Clerk to the Authority as soon as possible).
