1. DECISION

To appoint Prometheus Group Services LTD to undertake the installation of a new heating system at Audley junior and infant school.

2. REASON FOR DECISION

The tender specification for the provision of a new heating system at Audley Junior and Infant school was advertised on the Chest procurement system.

Nine submissions were received in response to the Invitation to Tender. These were evaluated on a 70% price and 25% quality basis and 5% social value, see table below.

Following an evaluation of the returned tenders, Prometheus Group Services Limited are the successful contractors.
