SUBJECT: Contract Award - Carriageway Inlay Project via BwDBC Surfacing and Civils Framework

1. EXECUTIVE SUMMARY

Using lot 1 of the Surfacing and Civils Framework, a mini-competition was published on The Chest inviting all three available contractors to bid for the works contract. All three contractors submitted compliant bids and based on the evaluation criteria of 100% price, Aggregate Industries UK Ltd are in first place with a total price of £298,291.92. The tender returns were deemed to be very competitively priced and it is therefore, suggested that the works contract is awarded to Aggregate Industries UK Ltd.

2. RECOMMENDATIONS

It is recommended that the Executive Member approves the award of the Carriageway Inlay Project Contract to Aggregate Industries UK Ltd through the BwDBC Surfacing and Civils Framework.

3. BACKGROUND

In May 2023 the Council established a Surfacing and Civils Framework that consisted of 4 lots with up to 3 contractors per lot. A breakdown of the lot structure and the suppliers on each lot is below.

Lot 1 - Surfacing:

- Tarmac Trading Limited
- Bethell Construction Limited
- Aggregate Industries UK Ltd

Lot 2 - Civils:

- Bethell Construction Limited
- Multevo Ltd
- A E Yates Ltd

Lot 3 - Surface Dressing:

Road Maintenance Services Ltd

Lot 4 - Specialist Surface Treatments:

Every works package that is available through the Surfacing and Civils Framework is sent to all available contractors on the applicable lot via The Chest e-tendering system. This gives every contractor an opportunity to bid through a further competition exercise and ensures BwDBC are achieving value for money.

The evaluation criteria used to create the Surfacing and Civils framework had a focus on quality to ensure the most competent contractors were selected. The evaluation criteria used is set out below:

- Quality 60%
- Price 25%
- Social Value 15%

Due to the focus on quality when constructing the framework and satisfaction that the highest quality contractors have been selected for each lot, the evaluation criteria used for this particular works package was 100% price. This ensures that the contractors are focussed on submitting their most competitive price and ultimately, delivering the best value for money for BwDBC.

This Scheme will cover the resurfacing of highways on:

- A666 Darwen Town Centre (near Cochran Street), Darwen;
- Audley Range, Blackburn;
- Harrison Street, Blackburn;
- Preston Old Road, Blackburn.

And will encompass the following works:

- Carriageway inlay resurfacing;
- Adjustment and/or replacement of ironwork;
- · Replacement of road markings;
- Liaison with stakeholders and the public;
- Traffic management.

The Works are envisaged to commence on 18th September 2023 with Completion of the works by 19th November 2023.

4. KEY ISSUES & RISKS

The Highways Team identified an extremely low rate for one particular item within the Bill of Quantities submitted by Aggregate Industries UK Ltd as part of their tender return. This risk was identified and subsequently, the Council have communicated with the Aggregate Industries UK Ltd via The Chest, who have clarified that they stand by their original submission and can hold the rate.
